## Terms of resignation from participating in the Convention of the Polish Association of Agricultural and Agribusiness Economists:

- 1. A decision about resignation from participating in the Convention of the Polish Association of Agricultural and Agribusiness Economists should be submitted in writing to: <a href="mailto:sekretariat@seria.home.pl">sekretariat@seria.home.pl</a> by May 31, 2023 by the latest. After that date, the payments made will not be returned.
  - a) In the case of a complete resignation from participating in the Convention before **May 31, 2023** and not submitting a paper for publication, a handling fee of PLN 200 will be charged.
  - b) In the case of a complete resignation from participating in the Convention before **May 31, 2023** and receiving a negative review of the paper, a fee of PLN 500 will be charged.
- 2. A request for the return of payment should be made in writing to: <a href="mailto:sekretariat@seria.home.pl">sekretariat@seria.home.pl</a> by May 31, 2023 at the latest. After that date, the payments made will not be returned.
- 3. Changing the variant of the participation in the Convention is possible until May 31, 2023.

Such changes should be reported to the Organising Committee of the Convention up to seven days before the start of the Convention.
