#### **ROUTE 1 – *Activities of the local authorities in Krakow during the pandemic***

presentation of the history and development of the city of Krakow, the itinerary includes: a guided tour of Krakow's Market Square and the exposition of the Historical Museum of Krakow – Rynek Underground, a meeting with representatives of the local authorities and a walk with a tour guide – Wawel, Kazimierz.

Leaving at 8:00 a.m., return at around 4:30 p.m.

#### **ROUTE 2 – *Local development illustrated with an example of the town of Zator***

learning about the history of the dynamic development of the town of Zator, which, thanks to the activities of the local leaders, was transformed in less than 20 years from a forgotten place to one of most visited towns in Poland; the itinerary includes: a walk around Poland's largest amusement park ENERGYLANDIA, a drive through the Zator Economic Activity Zone and learning about the activity of the Carp Valley Association.

Leaving at 9:00 a.m., return at around 4:00 p.m.

Papers not submitted to the editorial staff as part of participation in the Convention by 31 December 2022 will not be published.

**Terms of resignation from participating in the Convention of the Polish Association of Agricultural and Agribusiness Economists:**

1. A decision about resignation from participating in the Convention of the Polish Association of Agricultural and Agribusiness Economists should be submitted in writing at: [sekretariat@seria.home.pl](mailto:sekretariat@seria.home.pl) by **31 May 2022 at the latest**. After that date, the payments made will not be returned.
- a) In the case of a complete resignation from participating in the Convention before **31 May 2022** and not submitting a paper for publication, a handling fee of PLN 200 will be charged.
- b) In the case of a complete resignation from participating in the Convention before **31 May 2022** and receiving a negative review of the paper, a fee of PLN 500 will be charged.
2. A request for the return of payment should be made in writing at: [sekretariat@seria.home.pl](mailto:sekretariat@seria.home.pl) by **31 May 2022** at the latest. After that date, the payments made will not be returned.
3. Changing the variant of the participation in the Convention is possible until **31 May 2022**.

Such changes should be reported to the Organising Committee of the Convention up to seven days before the start of the Convention.
